CALL TO ORDER

ADOPTION OF AGENDA

Upon a motion duly made and seconded, the agenda was accepted without changes.

CONSIDERATION OF MINUTES

Upon a motion duly made and seconded, the Board Meeting minutes from June 22, 2016, were approved.

CONSIDERATION OF ELECTRONIC VOTES

The policy for the contracting subcommittee was approved on July 5, 2016

PRESIDENT'S REPORT

- Reauthorization to cash WNB 50k CD and reduce loan; FSR will check on the process for paying off notes
- Authorization for clubhouse assistant manager position and manager vacation approval was considered; other options should be explored
- Fence turn over to homeowner's final letter. The punch list is complete and now need warranty coverage.
- The Strategic Plan has been updated and is out for review by the leadership team for further discussion
- New members on the financial committee are Huda Pringle and Jo DeKumder

TREASURER'S REPORT

David Dommert explained the 2015 Audit Review which will be performed by Goldstein. A review saves \$3000-\$4000 as opposed to doing a full audit. It was noted that Rusticscapes submits their invoices late

- The rose bushes near the pool will be redone
- FSR will check on HR rules for full and part-time employees
