ADOPTION OF AGENDA

Upon a motion duly made and seconded, the agenda was accepted without changes.

CONSIDERATION OF MINUTES

Upon a motion duly made and seconded, the Board Meeting minutes from May 25, 2016, were approved.

CONSIDERATION OF ELECTRONIC VOTES

Truegreen contract for disease control on landscaping.

Upon a motion duly made and seconded, the Truegreen contract for \$490.00, was approved.

PRESIDENT'S REPORT

Upon a motion duly made and seconded, the Fence Task Force was dissolved.

OPEN COMMENTS BY BOARD MEMBERS

The financial statements, as prepared by FirstService Residential, are disappointing and the Board would like to see a vast improvement in the status of these reports immediately. Numerous times this issue has been brought to the attention of FirstService but they have not improved this service to an acceptable level.

TREASURER'S REPORT

Ron Gerlach reported that total operating income for April was \$144,631.01. The Total Expenses for the same time were \$119,337.42. The reserve balance on May 30 was \$551,188.20.

MANAGEMENT REPORT

Matt Lopez, Manager from First Service Residential reviewed the process and procedure for inspections. President Ron Gerlach stated that in the near future a resident volunteer may be available to assist with inspections.

CLUBHOUSE MANAGER'S REPORT

Nancy Triggs reported that it would be nice to purchase adobe acrobat software for use in the office and Board felt this was a good use of resources.

Upon a motion duly made and seconded, the Activity Calendars in Nancy Trigg's packet, were approved through December 2016.

Upon a motion duly made and seconded, the yearly Movie License was approved to be paid for in the amount of \$2759.87 for the next year.

COMMITTEE REPORTS

No reports were done at this time.

ADDITIONAL BUSINESS

Villas Master Updates – Fence Issues with the builder are still simmering and Ron Gerlach said he would follow up to try to finalize the last issues.

MUD #18 Updates – Mr. Gerlach reported that some older bonds are being reissued at a lower rate and the MUD#18 Board expects to be able to lower the tax rate again this coming year. This will provide the homeowners a little relief.

Homeowner Concern Forms - Billy Potter reviewed the homeowner concern forms and the status of each.

EXECUTIVE SESSION
