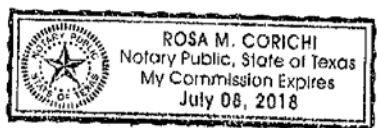

Amendment Number 2 to the March 2012 Amended and Restated By-Laws of BellaVita at Green Tee Homeowners' Association, Inc.

This amendment to By-Laws of BellaVita at Green Tee is made this 22nd day of February, 2017, by the BellaVita at Green Tee Homeowners' Association, Inc. Board of Directors.

Now Therefore Article III. A Composition and Selection. Section 4. Election and Term of Office. is amended by the following:

Delete Section 4. in its entirety and replace with the following:

All eligible members of the Association shall be given an opportunity to vote on all Directors to be elected, and the candidate(s) receiving the most votes shall be elected. Annually, the Association shall hold elections to fill the positions of Directors whose terms have expired. Each Director shall serve a term of three (3) years per the plan below. The members of the Board of Directors shall hold office until their respective successors shall have been elected by the Association. If at any time these Bylaws have been amended to increase the number of Directors or to change the length of the term of office, an implementation plan shall be developed to give effect to staggered terms. This implementation plan shall be implemented for the 2018 elections.

IMPLEMENTATION PLAN (2017)

2017 -- 3 positions elected -- elected for 2 year terms

2018 -- 4 positions elected

2 elected for 3 year terms who receive the largest number of votes

2 elected for 2 year terms who receive the 3rd and 4th largest vote count

2019 -- 3 positions elected -- elected for 3 year terms

2020 -- 2 positions elected-- elected for 3 year terms

2021 -- 2 positions elected-- elected for 3 year terms

2022 and subsequent, follow the election sequence of 3-2-2 for 3 year terms.

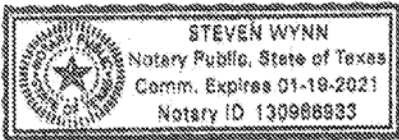
