ROSE AWARD 2018 GOES TO LINDA KUHN

What is the ROSE Award?

ROSE is an acronym for Recognition Of Serving Extraordinarily.

The ROSE is the highest form of recognition given by the BellaVita HOA to a person for an idea/solution/project that occurred in the prior year, 2018, and that directly benefits the entire BellaVita community and/or community life. These efforts are viewed as being "above and beyond" the normal service of homeowners.

Based on the ROSE Award criteria,

The Rose Award 2018 recipient has provided valuable ideas, has helped identify solutions which has benefitted and improve the community; all with a standard of professionalism and community spirit.

The 2018 Rose Award recipient's professional background, knowledge of environmental issues, and love of wildlife both enable and inspires this person to serve the BellaVita community. By using her remarkable skills, Linda serves in a unique way which really benefits all residents.

Linda Kuhn has been an active member of the Grounds Committee for several years. Now, serves as an inspiring chairperson of the Nature Reserve Committee. Leads the committee that maintains the Harry Reed Audubon Trail and the Nature Reserve.

In 2018, Linda devised and implemented a novel project that will benefit all BellaVita residents. She has been the driving force in creating a Nature Observation Platform at the end of Ameno Drive. This project improves the aesthetics of our community. It encourages the use of and ease of access to the Nature Reserve for all residents who do not or cannot access the Nature Reserve trails. Now it has been designed by Linda, taking into consideration ADA requirements. The project has three defined phases:

Phase 1: Via Linda's direction, the volunteers joined to bring to fruition a butterfly/hummingbird garden at the end of Ameno Drive. Cheerful butterfly benches (donated) and decorative boulders and border stones have been installed to make quite a statement. In the garden, native vegetation has been chosen to attract butterflies. Now a lovely spot for residents to sit and take in nature.

Phase 2: To remove and replace the unsightly barricade at the end of Ameno Drive. This is definitely an improvement to the aesthetics of the environment since the barricade is being replaced with large natural boulders and an entrance to invite all residents to enjoy the sights of our home habitat on the new Observation Platform.

Phase 3: Construction of the Observation Platform including built in seating and access boardwalk. She has solicited donations for funds from BV clubs and individuals for the platform. Donations are now over \$10,000. However, additional funds are needed to ensure the completion of construction. As the Nature Reserve Committee has communicated, large or small donations are appreciated.

As well as this large project, Linda has installed several Blue Bird boxes (made by the Girl Scouts and guided by the BV Birders). Also, she has installed Wood Duck boxes in the Nature Reserve which have produced eggs.

Linda has nursed birds, squirrels, screech owls and other local animals back to health. The survival of the creatures who share our environment is very valuable to us in keeping our ecosystem sound. Even the front desk and others know who to contact when a creature is in distress.

For tireless dedication and caring efforts to the environmental improvements of the BellaVita community, we recognize Linda Kuhn as the Rose Award 2018 winner.

AMENDED COMPLIANCE POLICY

From Connie Harry, President HOA Board of Directors

The Board of Directors adopted an amended Compliance Policy to institute fines for homeowners reluctant to adhere to notice letters regarding restriction violations. The following is an excerpt of the Compliance Policy. This document has been filed for record in the County Clerk's Office as required by law and is published on our BellaVita website.

This article is being published by the Board to provide adequate notice to Homeowners regarding the adoption of this Compliance Policy. This policy will be instituted beginning May 1, 2019 for citations issued after that date.

"Article XII of the Amended and Restated Declarations of Covenants, Conditions, and Restrictions for BellaVita at Green Tee Homeowners'
Association, Inc. authorizes the Board of Directors of BellaVita to take actions to ensure that homeowners within BellaVita remain in compliance with the established community-wide standards and rules, including imposing fines, restricting usage of common facilities, and initiating legal actions to obtain injunctive relief.

For a violation that continues from day to day without intervening activity by the homeowner, management company will take the following steps:

An initial notice of the violation shall be mailed via regular mail requesting compliance and/or an ARC application within 30 days and, as a courtesy, no fines will be imposed. Management company will provide a list detailing all initial notices to the BellaVita Board of Directors. The validity of the violation will be independently verified by the BellaVita Board of Directors and/or the Architectural Review Committee.

If the violation has not been corrected within 30 days and the validity of the violation has been independently verified by the BellaVita Board of Directors and/or the Architectural Review Committee, a second notice shall be mailed via regular mail and mailed via certified mail, return receipt requested. The second notice will satisfy the requirements of Chapter 209.006 of the Texas Property Code and will request compliance within 30 days and it will include disclosure that the homeowner may appeal the notice; fines will be imposed effective 30 days after the date of the second notice; and other legal actions may result from non-compliance.

Management company shall assess fines for violations as follows:

If the violation has not been corrected within 30 days from the third notice, management company shall submit the issue to the Board of Directors for consideration of legal action at its next scheduled meeting. Management company shall provide copies of correspondence and other documentation at least 5 days before the meeting so that Directors can familiarize themselves with the violation.

(continuation paraphrased to include the following: If the violation is interrupted by partial compliance but later cited for the same violation, it will be assumed to be the same violation with the schedule for notices and fines the same as above).

(Continued paraphrase – homeowner has the right to submit written appeal to the management company to protest the fines. Management Company will have 30 days to make its findings. The homeowner may subsequently appeal to the Board of Directors, whose decision will be final).














BELLES LITE MOVIE NIGHT



PLEASE DO NOT FEED THE STRAY ANIMALS!

By feeding stray cats, racoons, opossums, etc., you create unwanted messes in your yard and your neighbors yards. Stray cats that are being fed tend to make litterboxes out of gardens, plants, rooftops, patio furniture, and worse, garages. Feral cats can also damage outside furnishings by scratching and spraying on them, leaving an unpleasant odor. Neighbors with damage from these strays may use necessary means to remove the unwanted pests to avoid further damage by calling Animal Control or using an animal safe trap. Traps are often available at no charge from the City.

The Rules and Regulations governing the use of BellaVita property (clubhouse, annex, pool and common grounds) state that no more than 10 guests per household are allowed. Exceptions to this rule are for Bereavement/Memorial services, private party rentals and events open to the public such as the Mistletoe Market. Your private homes are not governed by these Rules and Regulations.



Drink of the Week APRIL FOOL'S MARTINI

INGREDIENTS:

1.5 oz Don Julio Blanco Tequila

.5 oz Green Chartreuse

5 Basil leaves

1 oz Ruby red grapefruit juice

.75 oz Lime juice

.75 oz Simple syrup (one part sugar, one part water)

Garnish: Thin apple slice or maraschino

In honor of April Fool's Day we decided to mix up some trouble. Sure, we could have filled your vodka bottles with gin or added hot sauce to your whiskey, but those tricks are for amateurs. Instead, we challenged Aisha Sharpe, our advisor and co-founder of drinks consultancy Contemporary Cocktails, to come up with a cocktail that tricks both the eye and the palate. No matter how many times you read the recipe, when you see her Apple Fool's Martini you expect to taste a cloying sweet Apple Martini. But her drink—which calls for tequila, Chartreuse, ruby red grapefruit juice and basil—is distinctly herbal with a spicy and tart kick. Maybe it's the apple slice garnish but Sharpe gets us every time. The good news is that this drink is both a trick and a treat.

All specialty papers are to be provided by the requester.


